Game day expenses per participant may vary from sport to sport. This may be due to distance traveled per team or schedules. This may also be due to teams qualifying and traveling to National Tournaments. Due to Covid-19 Volleyball and Basketball were moved to the spring of 2021, with a reduced number of dates played and no overnight trips.

Debt service and capital expense are not included in these totals.
